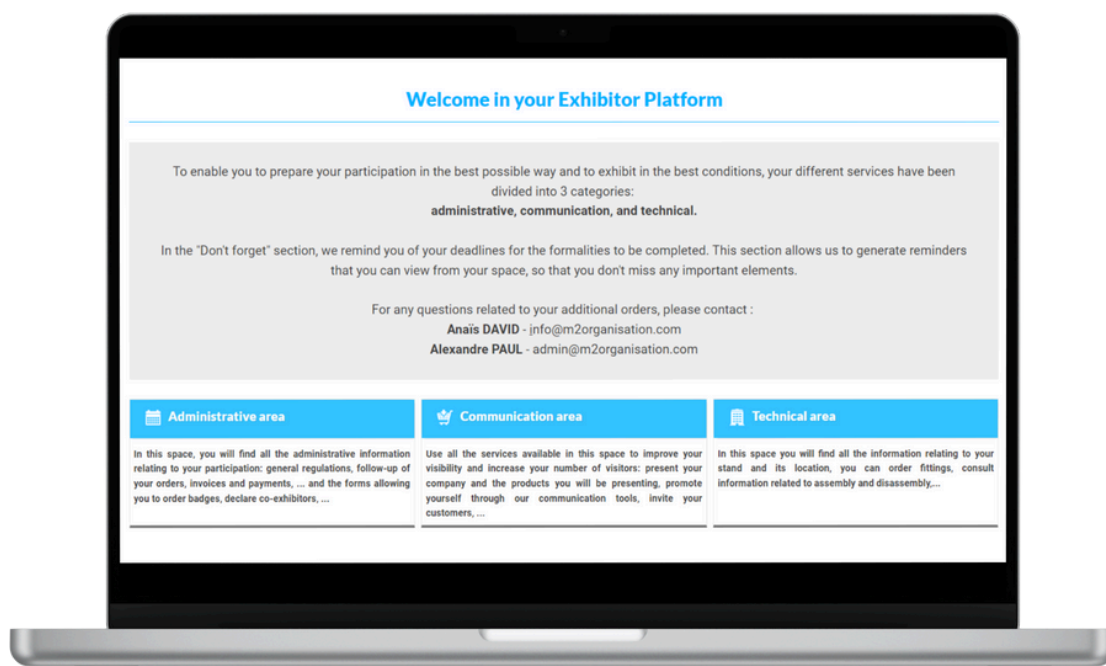

SPECIAL RULES OF THE EXHIBITION

PREAMBLE

Established by the Fédération des Industries Nautiques on the proposal of M2Organisation, represented by the Director of the Show in charge of its application, these regulations set out the specific conditions of the provision of services provided to the exhibitor by M2Organisation. It is supplemented, in the event of a gap, by the additional provisions of the General Regulations for Commercial Events (RGM/2015) of UNIMEV, the professional federation of event organizers (see <http://www.unimev.fr/>). These regulations form an inseparable whole.

Article II

General conditions of admission Unless exempted from M2Organization and the Fédération des Industries Nautiques, only companies and groups of companies regularly constituted and registered in the Trade Register for more than one year and whose activities have a direct relationship with navigation pleasure craft and nautical tourism as well as training in sea and water professions can be admitted to exhibit at the Show. All new exhibitors must attach to their registration file a Kbis extract dated less than 3 months (or for foreign exhibitors an equivalent document), detailed documentation on their products or services. Admission is personal. Groups of companies (G.I.E, Associations, etc.) can only exhibit collective spaces if each company, member of the group, has been individually admitted to exhibit and has agreed to pay the obligatory fees. Foreign business groups can only exhibit in the spaces if their companies do not have importers or agents in France, unless an exemption is granted by M2Organization and the Fédération des Industries Nautiques. Digital requests for participation are submitted to M2Organisation and the Fédération des Industries Nautiques which, after examination, decide whether to accept them or refuse them. M2Organisation and the Fédération des Industries Nautiques reserve in particular the right to refuse the admission of companies experiencing financial difficulties, in particular those under its judicial administration which do not offer sufficient guarantees of proper performance of their obligations.

Article III

Registrations and financial commitments Digital requests for participation must be completed no later than February 27, 2026. They must be accompanied by the deposit mentioned in the request for participation. Requests for participation received after this date will be satisfied, subject to their admission under the conditions described above, depending on the available locations and the order of arrival of the requests. They must be accompanied by the deposits due on the date of their sending.



Any payment received from a company that has not paid the sums due for its participation in a previous session will be applied as a priority to the payment of these sums. Unless the organization refuses the requested participation, sending the request for participation constitutes a firm and irrevocable commitment to pay the entire total price including tax of your exhibition space reservation and related costs (Article 02- 02 of the General Exhibition Regulations).

The request for participation must be accompanied by the deposits due on the day of sending and bear your electronic signature.

✓ Deposit to attach to your participation request – 50% of the total amount including tax

✓ Balance as of March 13, 2026 – 50% of the total amount including tax

- In the absence of payment by the due date, the organizer may consider, without further formality, the membership as terminated and resume free use of the allocated locations, without prejudice to the exercise of its other rights.

Terms of cancelation :

The Organizer may cancel or postpone the event if it notices a noticeably insufficient number of registrants. The registered exhibitor will then be refunded the amount of their deposit or participation. The Organizer may also cancel or postpone the event in the event of force majeure. The following constitute cases of force majeure at any time: the cancellation or postponement of the event, any new economic, political, social situation at local, national or international level, not reasonably foreseeable, independent of the will of the event. organizer, which makes it impossible to carry out the event or which entail risks of disturbances or disorders likely to seriously affect the organization.

Article IV Ships and boats

- All pleasure craft must be approved by the Maritime Affairs Department and be equipped with a nameplate. Access to the International Multihull Show (IMS) may be refused to boats without this plate.
- Boats or pleasure craft without an engine, of a gross tonnage equal to or greater than two tons, or those equipped with an engine with a real power of more than 10 HP, must be approved and equipped with a nameplate. Access to IMS may be refused to boats without this plate.

Vessels under approval

1) Vessels over 5 m long, other than light and inflatable sailboats: attach to the registration file a copy of the receipt for submitting the approval file to the National Commission for Safety of Pleasure Boating.

2) Vessels over 5 m long, sailboats and inflatable boats: attach to the registration file a copy of the approval report established by the ship safety center on which you depend. In any case, exhibitors of pleasure craft are asked to complete the technical sheet “boats afloat, on land and various gear” precisely. No registration will be recorded by the organization if this form is not duly completed.

Article V Obligations of the participant

- Any registration form given definitively and irrevocably binds its subscriber. Signing a registration form entails the obligation to occupy the stand or allocated location as well as to leave it installed until the end of the closing day of the show.
- Cancellation conditions: Any organization wishing to cancel its participation must do so by registered letter with return receipt. If the cancellation is made before February 10, 2026.



the 50% deposit will remain due. If the cancellation is made from February 10 of 2026, the entire payment will remain due.

- In the event of non-payment, the organizer reserves the right to dispose of the corresponding space.
- Participants are strictly prohibited from packing and/or dismantling the stand before the close of the show.
- During opening hours, the stand must be permanently occupied by the exhibitor and his staff. The exhibitor is responsible to the organizer for the running of his stand.

Article VI Allocation of locations

M2Organisation establishes the plan for the event and its sectoring. The allocation of locations is made by M2Organization by delegation of the Fédération des Industries Nautiques, in accordance with the provisions of article 04-01 of the General Regulations and the distribution of sectors of activity at the Show. Under no circumstances will an exhibitor or a group of exhibitors be able, under any pretext whatsoever, in particular precedence, to claim its location from previous years.

The Organizer will endeavor to satisfy the wishes of exhibitors to the fullest extent of the possibilities offered. The Organizer may modify this distribution and the allocated locations at any time. The plans communicated and the designation of the exhibition spaces include, if the location of the event is suitable, dimensions as precise as possible. The organizer cannot be held responsible for slight differences which may be noted between the dimensions indicated and the actual dimensions of the location, nor for modifications occurring in the environment of the stands (modification of neighboring stands, reconfiguration of aisles). as registrations are recorded. The m² subsequently accepted and exceeding the surface area initially requested will be invoiced additionally, at the price per unit m² for the use chosen.

Occupation :

The allocated spaces cannot be transferred, sublet or made available for payment or free of charge to a third party in whole or in part, by the exhibitor. It cannot carry out any advertising or commercial action in favor of a third party or products or services other than those for which the stand request was made, without prior agreement from M2Organization and the Fédération des Industries Nautiques. Requests for exemption must be made with the Request for Participation by completing the "List of co-exhibitors" section. M2Organisation and the Fédération des Industries Nautiques reserve the right to accept or refuse, without having to give reasons for its decision in the event of refusal, accommodation by the exhibitor of a co-exhibitor. If the accommodation request is granted, the exhibitor is and remains the sole contractor and the sole contact for the Organizer.

Article VII Installation rules

The installation of the spaces must in no way damage or modify the permanent installations of the place. The space allocated to exhibitors must be left after dismantling the stands, in the condition in which it was delivered. All work to renovate a location will be invoiced to the exhibitor occupying this area.

Signs and posters:

It is prohibited to place signs or billboards outside the stands or your exhibition space, without prior agreement from the Organizer.



List of boats on display – Boat arrival schedule:

No allocation of space can be made in the absence of a list of boats on display, completed precisely. M2Organisation declines all responsibility in the event of non-compliant declaration. The Organizer draws up the schedule for the arrival of the boats on the site.

Assembly and dismantling of stands:

Exhibitors can access their allocated space on Monday, April 20. Stand setup should be finished by 6:00 p.m. on April 21. Stands are to be disassembled at the conclusion of the event, between 6:00 p.m. and 10:00 p.m. on Sunday, April 26, and from 8:00 a.m. to 12:00 p.m. on Monday, April 27. Any items or structures not retrieved promptly will be stored by the Organizer, with associated costs billed to the exhibitor.

Article VIII Prospectus et haute parleurs

The distribution of documents can only be done inside the stands. These documents can only concern the items on display. Advertising loudly or by loudspeaker, as well as soliciting and noisy events are strictly prohibited.

Article IX Assurances

- M2Organisation has taken out a collective insurance policy guaranteeing the property belonging to exhibitors, as defined below, against loss or damage resulting from fire, lightning, explosions, water damage, damage or destruction due to accidental causes, or as a result of attacks, terrorism and natural disasters. It is therefore up to the exhibitor to guarantee against the risk of theft.
- The goods designated below are guaranteed in the location they must occupy on the exhibitor's stand, for a period starting the day preceding the opening, and ending on the day the show closes.
- The goods covered by the guarantee are :
 - ✓ the goods, products, equipment on display belonging to the exhibitor.
 - ✓ stand layout, installation and decoration equipment, as well as computer or audiovisual equipment belonging to the exhibitor, on the express condition of making a declaration and allocating special capital.
- M2Organisation must take out insurance on behalf of the exhibitor for a guarantee of a maximum amount of €3,000 per request for participation, for the goods described above. If for these goods, the exhibitor wishes to have a guarantee for the losses designated at the beginning of this article, and this for a value greater than €3,000, he must make an express declaration of this to the organizer. In the absence of this additional insurance, in the event of a claim, the proportional rule will be applied. A damage excess of €150 will be deducted from any claim.
- The boats exhibited will be insured by the owners, exhibitors, resellers. These therefore exclude any recourse against the organizer and will therefore directly bear any damage that may occur during the Show. Excluded from the warranty :
 - Theft, against which the exhibitor must insure.
 - Diseases and mortality of animals as well as accidents that they could possibly suffer.
 - Damage caused by civil or foreign wars, floods, hurricanes, downpours or cyclones, any effects due to an atomic explosion, etc...
 - Damage resulting from the inherent defect of the insured objects, leakage of liquids, damage due to insufficient packaging, deterioration resulting from scratches or scrapes, damage caused to the insured objects outdoors by rain, hail or other atmospheric manifestation, as well as the consequences of humidity, it being specified that rust remains covered, inside the stands, if it results directly from water damage characterized.



- Losses resulting from fines, confiscation or sequestration.
- Losses resulting from shortages in stands where distributions or tastings of any goods or drinks are carried out.
- Damage or destruction resulting from the assembly or dismantling of the exhibits.
- The risk of breakage with regard to fragile objects such as marble, porcelain, earthenware, plaster, wax, terracotta, ceramics, alabaster, stoneware, glassware, mirrors, wax mannequins, apparatus, scientific instruments or the like, as well as cast iron objects or parts of objects.
- Damage suffered by objects or devices of any kind as a result of their operation, all damage resulting from mechanical or electrical disruption of the insured objects, as well as breakage of bulb filaments and all damage to electrical or electronic tubes.
- Personal effects and objects, bank notes, cash, jewelry, cameras, radio devices, electronic pocket calculators and all objects in general belonging to any natural or legal person participating directly or indirectly in the show • damage caused to fabrics, clothing, furs, carpets, tapestries, floor coverings, walls or partitions by stains, dirt as well as by burns from cigarettes or pipes, except resulting from water damage or fire.
- By the sole fact of their registration, exhibitors expressly waive any recourse against the organizer and its insurers in the event of fire or explosion resulting from a construction defect or a lack of maintenance of the stands that they they occupy (art. 1721 of the Civil Code). In return, with regard to the buildings made available to exhibitors, it is specified that the port management body of the host city waives any recourse it could exercise against exhibitors responsible for a fire or damage. 'an explosion. He has signed a contract which includes a clause waiving recourse that companies subrogated to the right of owner could exercise against exhibitors, under articles 1302, 1732 et seq. of the Civil Code. Exhibitors therefore do not have to guarantee their rental liability.
- As soon as a claim is discovered, a written declaration must be filed (a blank claim declaration will be available for download on your exhibitor portal): at the police station of the host city; at the Salon's general police station.
- After a period of 5 clear days after the end of the event, no declaration will be accepted.

Article X Attribution of jurisdiction

- All disputes that may arise between the member and the organizer will be brought before the courts of Nantes, the sole competent courts by express agreement between the parties.
- The exhibitor expressly refrains from taking legal action before having first implemented an amicable conciliation procedure.

Article XI Exhibitor badges and invitations

- Exhibitor badges will be available for download on the exhibitor platform.
- Exhibitors will be able to purchase invitations for the people and companies they wish to invite. Unused invitations cannot be returned, exchanged or refunded. The distribution and/or sale of invitations issued by the Organizer is strictly prohibited within and around the event. Reproduction or sale of these special invitations and cards may result in legal action. Only the Show Organizer is authorized to issue invitations and special cards meeting a specific need. Any infringement and/or fraud observed may result in criminal prosecution.



TERMS OF SALES

These conditions apply to the sale of advertising space in products derived from the International Multihull Show (print and digital communication tools, etc.) as well as on the website accessible at the address [https://www .multihull-online.com/fr/](https://www.multihull-online.com/fr/).

The derivative products and the website of the International Multihull Show are hereinafter referred to as: "Communication tools". Any request for advertising insertion in the communication tools of the International Multihull Show is deemed firm and irrevocable by the advertiser as soon as it is recorded by M2Organisation. If this request is made by an agent, it is jointly binding on the latter and the advertiser, in particular for the proper payment of this advertisement. The agent must act under cover of notification by the advertiser who must specify the scope and duration of his mandate. In the event of a contradiction between these general conditions of sale and the purchasing conditions of an advertiser, it is agreed that these general conditions of sale prevail.

The advertiser undertakes to provide the documents or types necessary for the printing and/or posting online of its advertising message for the planned dates. Any technical costs will be the responsibility of the advertiser. The advertiser must respect the requirements of M2Organisation set out in its commercial documents concerning the supply of technical elements (e.g.: format of advertising banners).

If the production of the announcement is monitored by the communication services of the International Multihull Show, a proof may be presented to the advertiser who must indicate any modifications by return. Failure to return within 5 days implies tacit acceptance.

In the event of non-compliance with the delivery dates of technical elements, an announcement including the company name and contact details of the advertiser will be made at their expense. Deadline for posting online: 3 working days from receipt of technical elements.

In the event of cancellation of an order for any reason, the 50% deposit remains with M2Organisation. M2Organisation declines all responsibility for technical elements which have not been recovered by advertisers or their agents within three months from the last insertion.

The registration by M2Organization of an advertising insertion request only gives the advertiser the right to occupy the space reserved for it. The locations, forms and methods of displaying the proposed insertions as well as the related prices are detailed in the order form attached hereto.

The prices do not include technical costs such as any costs for creating and producing insertions. Apart from the locations provided for in the publication rate, no position can be guaranteed, regardless of the stipulations made by the advertiser on the advertising insertion request. The text and illustrations of an advertisement and in particular the brands and names, are published under the sole responsibility of the advertiser. In particular, any reproduction rights for photographic documents are the responsibility of the latter. It guarantees them against any recourse from a third party relating to the content of these advertising insertions. The advertiser therefore undertakes to ensure, at its own expense, the defense of M2Organisation, the publisher, the printer or any third party in the event that the latter are the subject of an action or claim relating to the content, to data, information, messages etc. advertising insertions and to pay the compensation due in compensation for any damage suffered. M2Organisation cannot be held liable for more than a total amount corresponding to 1/6th of the total annual amount received for the service, excluding the extension or renewal period.

Any error made by M2Organisation, the publisher, the printer or a third party in an advertisement cannot lead to its cancellation. The correction will be made in the following catalog or advertising products. No complaint will be accepted if it is not made in writing within 8 days following the date of insertion or the date of posting online.

Any delay, suspension or cancellation in the broadcast of the advertising insertion due in particular to technical failures inherent in the operation of the Internet network, external to M2Organisation and independent of its will, cannot motivate a refusal of payment, even partial on the part of the advertiser or his agent, nor give rise to the right to a new insertion at the expense of M2Organisation or to compensation, in any form whatsoever, from the advertiser or his agent.

M2Organisation cannot also be held responsible for accidental or deliberate damage caused to the advertiser by third parties due to or by their connection to the Internet network. The advertiser waives any recourse against M2Organisation or a third party, due to loss, destruction, damage or harm resulting from the interruption or disruption of the activity, caused directly or indirectly, consisting of or arising from the failure of any computer, data processing equipment, multimedia microcircuit, operating system, microprocessor (computer chip), integrated circuit or similar component, or any software, whether or not owned by M2Organisation.

In accordance with the Data Protection Act No. 78-17 of January 6, 1978, the advertiser has the right to access, modify, rectify and delete personal information that concerns him. To exercise this right, the advertiser must contact M2Organisation. M2Organisation is free to refuse, in accordance with press and publication practices, the insertion of an advertisement without it being necessary to have to justify its refusal.

Locations are assigned based on advertiser booking dates. Invoices are established based on these reservation dates and must be paid upon receipt. In the case of an advertiser using an agency mandated by him, the invoice will be sent to the agency with a copy to the advertiser. Advertisements are payable 50% of the amount including tax upon delivery of the order form and the balance upon receipt of the invoice. Failure to pay on the due date will result in the entire debt becoming immediately payable and compensation set, as a penalty clause, at 10% of the amounts due and unpaid. Any late payment will result in the application of a late payment penalty at a rate equal to one and a half times the legal interest rate. The debtor in a situation of late payment will be liable, as of right, for a fixed compensation for recovery costs of 40 euros. In cases where the recovery costs incurred are greater than 40 euros, M2Organisation may request additional compensation from the debtor, upon receipt of proof. In the event of a dispute, the Nantes Commercial Court has sole jurisdiction. Any request for advertising insertion implies acceptance of the general conditions above.
